1. BACKGROUND

Government of Andhra Pradesh has established a Joint Venture company called Andhra Pradesh Urban Infrastructure Asset Management Limited (APUIAML) under Companies Act 2013 with the objective of development of infrastructure projects, attracting investments and financing of Urban Infrastructure Projects in the State by appointing the Chief Secretary as Chairman and Principal Secretary MA&UD, Principal Secretary Finance as nominees on Board of the Company.

APUIAML is providing End-to-End Transaction Advisory (TA) Services to various Government Departments for infrastructure projects comprising of buildings, roads, water supply/ sewerage works, Solid waste projects, tourism projects etc in the State of Andhra Pradesh.

In view of various ongoing works of APUIAML, it is proposed to engage agencies for conducting various Geotechnical Investigations in various Regions of Andhra Pradesh. The Geotechnical Agencies will be shortlisted for undertaking the Geotechnical Investigations Regionwise and for any Geotechnical Investigations for locations in a particular Region, the short-listed agency for that particular Region shall be issued Work Order for conducting the same.

2. SOLICITATION

As part of the detailing of various projects, it is required to carry out the Geotechnical Investigation in various Regions in the State of Andhra Pradesh as per the details given below:

APUIAML, based on ongoing Projects, shall identify the requirement of undertaking Geotechnical Investigations in various regions and instruct the selected agency for undertaking Geotechnical Investigations at various locations as and when the need arises

The number and type of Geotechnical Investigations in the Regions will be dependent on the projects APUIAML will be undertaking in those Regions. The details of investigations to be taken up shall be intimated to the empanelled bidder during the course of engagement period.

The bidder can apply for either one region or all regions. The Agencies will be selected Region wise.

3. RFQ Processing Fee

4. PROCESS OF ENGAGEMENT

Under this process, the agencies involved in conducting geotechnical investigations are invited to submit their proposals along with unit rates for various geotechnical investigations as mentioned in this RFQ for **each region.**

The agencies quoting the lowest rate as per their financial proposal will be shortlisted region wise and engage for a period of one year by APUIAML and in case of any geotechnical investigations are to be done in that Region, the agency will be requested to undertake the work as per the unit rates quoted by the Bidder.

For each region, it is proposed to select the lowest quoted agency (L1) based on the financial proposal submitted by the agency for the quantities mentioned in this RFQ. It may be noted that the quantities at this stage are indicative and are likely to change during the Agreement period. Rest of the qualified proposals will be ranked as L2, L3, L4...etc.

APUIAML shall finalize the L1 Bidder on a region-wise basis and declare them as the Empanelled Bidder 1. In addition, APUIAML shall also negotiate with the L2 Bidders in each region to explore the possibility of matching the L1 bidder's rates. Any L2 bidder who agrees to match the L1 bidder's rates shall be declared as the Empanelled Bidder 2.

Whenever APUIAML proposes to undertake any work, it shall first approach the Empanelled L1 Bidder. If the L1 Bidder is unable to undertake the work due to pre-occupancy with other assignments (outside of APUIAML), then APUIAML shall request the Empanelled L2 Bidder to undertake the work at the L1 bidder's rates.

If the L2 Bidder also declines to undertake the work due to pre-occupancy with other assignments, then APUIAML shall invite quotations from the open market in accordance with the Procurement Guidelines of APUIAML, to select an agency for that specific assignment.

However, if either the L1 or L2 Bidder declines to undertake the work on account of rate issues, then such bidder shall be blacklisted for a period of three (3) years, and will not be eligible to participate in any future tender processes of APUIAML during that period.

It is to be noted that, APUIAML reserves the right not to utilize the empanelled geotechnical agencies for any of its works and award the geotechnical works to any other agency during empanelled period.

The unit rates quoted by the shortlisted bidder are applicable for one year from the date of their engagement.

In this context, Technical Proposal and Financial Proposal are solicited to engage Agency(s) for conducting Geotechnical Investigations in various Regions mentioned above. The scope of work with key ToRs, General Conditions and Financial proposal formats are annexed.

6. BID SUBMISSION

The bidder is required to submit the proposal in two envelopes (Technical Proposal and Financial Proposal). The Technical Proposal envelope shall consist of **Annexures 1 to 6** and Financial Proposal shall be submitted in **Annexure 7**. Both the envelopes shall be put in an outer envelope and submitted to APUIAML. The Financial Proposal should be submitted by agencies on the office letterhead and duly signed by the competent authority and shall have the following contact information: (i) Contact Person Name and designation with seal (ii) Mobile No. (iii) email ID (iv) Address.

7. SITE LOCATIONS

The site locations shall be identified during course of empanelment period based on project requirement. As AP Government is one of the shareholders in APUIAML, it is expected to generate Geotechnical requirement for the agencies in various projects of APUIAML. However, it will be dependent on type and location of the Projects. Upon finalization of the requirement by APUIAML, the empanelled agency will be intimated for taking up the work as per the rates quoted by the selected bidder during this RFQ Process.

8. SCOPE OF WORK FOR THE AGENCY

Agency shall undertake a survey to mark the test locations on the field as per the requirement of the client.

The scope of work consists of 3 parts — Parts A, B and C

Part A-Mobilisation and Demobilization of Equipment and Personnel

- Mobilization of equipment and personnel to each project site, setting up the equipment and carrying out the field investigation and demobilization of the same after completion of fieldwork.
- All the labor, rig, water or any other equipment/infrastructure/material required for making borehole, transportation to site/ laboratory must be arranged by the Agency.

Part B- Sub surface explorations

- 1. All investigations shall be performed as per relevant IS, IRC standards. Scope of investigations generally shall consist of:
 - a. Drilling of exploratory boreholes of 150mm diameter by rotary drilling equipment through **all types of soils** except rock from existing ground level to a depth of maximum 10m or refusal below GL including collecting undisturbed samples (UDS) (in case of clayey strata continuous UDS is preferable), disturbed samples & every 3 m interval and SPT at every 1.5m depth interval under technical supervisor/Engineer of the agency, preparation and submission of site &final bore logs, preserving &transporting the samples to laboratory for further testing as per IS 1892-1979. The strata shall be treated as soil np to N value equal to 100 (SCR <10%)
 - b. Drilling in **boulders**/ **all type of rock**/ **SDR**/ **Weathered rock and hard rock** using NX casing bit including collection of rock core samples, logging in standard core log sheet, preserving &submitting the soil/ selected core samples to laboratory for carrying out required tests as per IS 10042-1981 GIS 4078-1980. This item is for strata having CR>10% but < 50% or RQD up to 30%.
 - c. Drilling in all types of hard rock with double core barrel using NX diamond bit up to a

depth of maximum 3m for confirmation of hard rock strata including collection of rock core samples, logging in standard core log sheet, preserving the cores in standard core box and submitting the same to laboratory for carrying out required tests as per IS 1892-1979 &IS 4078-1980. Hard rock shall be confirmed by having core recovery more than 50% or RQD greater than 30%.

- 2. All samples collected as per standards shall be preserved, labelled and following laboratory tests shall be conducted:
 - a. On Undisturbed Soil Samples (UDS):
 - i. Natural Moisture Content (NMC), Bulk Density & Specific
 - ii. Gravity
 - iii. Atterberg Limits
 - iv. Grain Size Analysis including Hydrometer analysis
 - v. Unconfirmed Compression Test/Direct Shear Test (UU/CD)/Tri- axial Test
 - vi. Consolidation Test
 - vii. Chemical analysis on soil water (Wherever required)
 - b. On Split Spoon Soil Samples (SPT):
 - i. Natural Moisture Content (NMC) & 5pecific Gravity
 - ii. Atterberg Limits
 - iii. Grain Size Analysis
 - c. On Rock Core Samples:
 - i. Core Recovery (CR) & Rock Quality Designation (RQD)
 - ii. Specific Gravity, Water Absorption & Porosity
 - iii. Unconfined Compression / Crushing Strength/Point Load test
 - iv. Modulus of Elasticity & Poisons Ratio of Rock (wherever required)
 - v. Assessment of RMR (Rock Mass Rating) value

Other points to be noted:

a. Agency operations should not cause any hindrance to other uses of land. As soon as the investigation work is completed all boreholes shall be backfilled to the satisfaction of the engineer.

- b. Agency shall deploy suitable/ qualified personnel to conduct the subsoil investigation and such personnel are to be skilled in the work. The work is to be done under the overall supervision of fully qualified post graduate geo-technical engineer with sufficient experience in making boreholes, conducting field tests, taking samples and identifying soils. The status of the investigation/ field work should be informed by the agency to the engineer- in-charge on daily basis. Format for submission of the data will be agreed by client.
- c. All facilities required to work at site shall be borne by the agency and shall not use any portion of the site for any purpose not connected with the works.
- d. Termination depth of each borehole shall be decided by the Engineer-in-Charge.
- e. Drilling of boreholes, recording observation data (time for drilling in rock should include in bore logs also), collection and preserving the undisturbed samples, numbering anti preserving the cores in standard core (boxes, preparation of bore logs and core logs shall be carried out strictly as per relevant IS standards.
- f. Undisturbed samples (UDS) collected at site shall be preserved such that no escape of moisture takes place and structure do not get disturbed. All Undisturbed samples shall be preserved in shade covered with moist hessian cloth.
- g. Agency shall provide at least one qualified geo-technical engineer and a geologist at site along with supervisors throughout the process of investigation.
- h. The work shall he commenced and completed as per the priority. In case of delay in progress of investigation, agency has to mobilize additional rigs to site, without any additional cost to client.
- i. Agency must inform to the engineer-in-charge before demobilization of plants /Machinery.
- j. In case at any stage, it is found that the progress and quality of work is not satisfactory, the work (in part or full whatever it may be) shall be withdrawn from the agency. No payment will be made against the completed works.
- k. Submit the draft report (soft & hard copy) for review; covering field/ lab test results in table & graphical form, silt factor, recommended foundation type and depth, SBC/ Pile capacity, site

observations, photographs of field and laboratory activities and all the core boxes etc., shall be included in the report.

- 1. Compiled final reports (soft & 3 Nos. of signed hard copies) shall be submitted after incorporating the observations from Client.
- m. Final report shall be submitted after incorporating the observations from Client.
- n. All data, information, documents, reports, specifications and similar materials etc. made under this contract are meant for this work only and upon completion of the work become the property of the Client. Agency may retain copies of said data or documents for his records, but such materials shall not be used by the agency for any other purpose.
- o. Agency shall take all the SPT/UDS samples and selected rock core samples from the core boxes for laboratory testing. The space occupied by the selected core samples should be labelled properly in the core box for easy identification, up to the satisfaction of Engineer-in-charge.
- p. Final report should also include the photographs of the investigation sites, ground water data and GPS co-ordinates as per the APUIAML benchmarks/ control network.

Part C: Test pits for original ground level

For the purpose of OGL soil investigations, test pits of size 1 m X l m are excavated on the proposed carriageway. Soil samples of about 60 kg are collected from the excavated pits and the following activities are to be carried out:

2. OTHERS

6.1 General Instructions

- All Geotechnical Investigations at each work location and data collection shall be carried out by the agency in the prescribed format agreed with APUIAML.
- The Calibration Certificate for the instruments used shall be submitted to APUIAML
- All data sheets shall be provided to APUIAML upon completion of each site works.
- All data needs to be entered by the agency in the format agreed with APUIAML.
- APUIAML representatives visiting the site shall be extended full cooperation and they shall be
 explained about methodology adopted and shall be appraised about the measures adopted for
 accuracy of work.
- The schedule of site works including should be approved by APUIAML before commencement of work.
- The quoted rates shall be inclusive of the cost of labor, materials, equipment, transport, insurance, punching of data in prescribed format, and reports etc. and no other charges whatsoever shall be entertained in any circumstances.
- The number of sample sizes to be collected and number of locations in each site location is subject to change at the time of issue of work order.

3. **DELIVERABLES**

- The data shall be submitted by the agency in the agreed format in agreed software.

- Survey Data Analysis Report shall be submitted by the agency in the agreed format
- The soft copy of the drawings, database and report in Word /Excel /PPT/Dwg/PDF /shape/Dbx. Etc. format needs to be submitted at each stage along with the above.
- The format for submission of the data and report shall be discussed and agreed with the client and the reports shall be in submitted in the format agreed upon.
- No other payment shall be made towards out-of-pocket expenses.

4. EFFECTING PAYMENTS TO THE AGENCY

• The payment to the Agency shall be paid based on milestone. APUIAML would approve for each deliverable for respective milestones.

5. DEDUCTIONS
